IN THE EVENT THAT THE DEFENDANT(S) SHOULD FAIL TO MAKE ANY OF THE FOREGOING PAYMENTS AND SHOULD SAID THE DEFAULT CONTINUE FOR A PERIOD OF MORE THAN **TEN (10)** DAYS AFTER WRITTEN NOTICE IS GIVEN TO THE DEFENDANT BY REGULAR MAIL AT **626 RXR PLAZA WEST TOWER 6 FL UNIONDALE NY 11556** THEN IN SUCH EVENT THE PLAINTIFF SHALL BE AT LIBERTY TO ENTER JUDGMENT FOR THE SUM OF RELIEF REQUESTED IN THE COMPLAINT, LESS ANY PAYMENTS MADE.


"Upon receipt of all required payments, your account will be considered settled and you will not be obligated to pay the remaining balance. The terms of this settlement will not be renegotiated at a later date. You must make all required payments by their agreed upon due dates. Payments submitted as a result of this settlement are not eligible for refund at anytime, except in an instance where the total of all payments made exceeds the total amount due under the terms of this settlement. If, as a result of this settlement, the amount forgiven or cancelled on this debt equals or exceeds \$600, the IRS may require FIA Card Services N.A. to report the amount forgiven or cancelled on a Form 1099-C. You will receive this form for the year in which the settlement is completed.
