**STIPULATION TO WITHHOLD  
ENFORCEMENT PROCEEDINGS  
AFTER JUDGMENT**

IT IS HEREBY STIPULATED AND AGREED between plaintiff's attorneys and undersigned party or his attorney, that the above action be settled on the following terms:

1. The plaintiff has duly obtained a Judgment against the defendant(s) in the amount of \$5,753.52
2. That the defendant(s) will pay the \$3,587.00 in full settlement to plaintiff's attorneys, MULLOOLY JEFFREY, ROONEY & FLYNN LLP, 6851 Jericho Tpke, Suite 220, PO BOX 9036, Syosset, NY 11791-9036.
3. That the sum of \$149.46 is to be paid on or before 12/05/17 (if by check, subject to collection) and the balance is to be paid at the rate of \$149.46 per month commencing 1/05/18 and continuing thereafter in equal monthly installments on the same day of each and every month until fully paid.
4. That as long as the defendant signing this stipulation makes payments in accordance herewith the plaintiff will not issue any executions or proceed with any examination in disclosure proceedings in furtherance of enforcement of money judgments or any contempt orders if such orders have been issued, and shall not issue any income executions against their salaries or institute enforcement proceedings under CPLR Article 52.
5. In the event of a default in any of the payments above, upon five(5) days written notice of default directed to the undersigned attorneys, or defendant(s), plaintiff's attorneys may pursue any and all steps necessary for the collection of the judgment balance, including prejudgment and post judgment cost, giving credit to defendant(s) for any payment made.
6. Upon payment in full in accordance with the terms hereof, or sooner if defendant(s) at any time pay the balance due on the said Judgment, plaintiff's attorney will issue a Satisfaction of Judgment procured in this action.
7. The parties agree that a facsimile copy of this stipulation may be used as an original.
8. This is an attempt to collect a debt and any information obtained will be used for this purpose.
9. There may be tax consequences as a result of a settlement. Please consult a tax professional if you have questions or want advice about any potential tax consequences.
